Scope of Work

The selected ISP will be responsible for:

- Providing high-speed dedicated internet access with specified download and upload speeds.
- Supplying dedicated IP addresses for each location.
- Meeting or exceeding the required speeds and service levels.
- Provide an SLA of five 9's or better.
- Provide 7x24x365 Support via phone.
 - Preferred support services will be US based

Dedicated IP Addresses

Proposals must include the provision of dedicated IP addresses for each of the above locations. Include the cost in the spreadsheet for a total of four dedicated IP addresses for each site.

Eligibility Requirements

Qualified vendors must meet the following criteria:

- Licensed to operate in Texas.
- Demonstrated experience providing high-speed dedicated internet services.
- Financial stability and capability to support the services proposed.
- Compliance with all relevant Texas state regulations and guidelines.

Proposal Submission Guidelines

Proposals shall be submitted in an Excel spreadsheet along with supporting documentation in .pdf format.

- Page Limits: Executive Summary (2 pages), Detailed Proposal (15 pages), Vendor Qualifications (5 pages)
- Include a table of contents

Proposals will be evaluated based on the following criteria:

- Compliance with RFP requirements
- Quality and reliability of service
- Cost-effectiveness
- Vendor experience and qualifications
- Customer references
- SLA terms

Contract Terms

The contract will be for an initial period of three years with an option for renewal. Payment terms will be monthly.
