What is CMHSN+

The primary focus is working collaboratively with DFPS to reduce the on-going crisis of children without placement (CWOP). Our efforts will focus on providing crisis intervention services, referrals to appropriate MH/BH professionals and linkage to LMHA/LBHA's within the required service area's.

The CMHSN+ will provide on-going mental health trainings covering a wide range of related topics (i.e. Crisis intervention, Understanding Youth & Adolescent MH diagnosis, Nurturing Parenting, etc.)

Scope of Grant Project:

What is the purpose of the CMH System Navigator Plus Program?

The Program was designed to support the provisions of services and treatment for children with behavioral health needs. The CMHSN+ is responsible for:

- Enhancing partnerships and promoting collaboration within child-serving systems including: LMHA's/LBHA's, DFPS, Independent providers (LPC's, Psychologists, Psychiatrists, etc.) PCP's, ISD's, Juvenile Detention/Probation, etc.
- Develop and Identify resources that support the continued provisions of services and treatment for children in conservatorship of DFPS lacking placement.
- Build on-going capacity in the LMHA/ LBHA through initial and continued training/education to direct care staff (DFPS, CPA's and QMHP's).
- Educate community Partners on the LMHA/LBHA's role in providing services to Youth and Adolescents.
- Promote an on-going integrated approach to care coordination, and collaboration with schools, family courts, health care service coordinators, primary care providers, etc.
- Conduction outreach within communities (provide MH/BH related trainings)

HOW WILL SERVICES BE DELIVERED?

The CMHSN+ will coordinate, facilitate or provide access to intake services that RAPIDLY connect Youth/Adolescents who are:

- in State conservatorship lacking placement.
- At risk of entering state conservatorship lacking placement.
- Are at risk of parental relinquishment.
- Or are in hospital's, intensive and outpatient programs.

to TRR authorized services as identified and in consultation with DFPS (Clinical coordinator/ Medical Consenter) to the appropriate LMHA/ LBHA.

The CMHSN+ complete routine check-in's with CWOP dept. for status update of Youth/Adolescents MH/BH.

The CMHSN+ will host regular meeting with LMHA/LBHA's to ensure appropriate coordination of intakes occurring and to obtain on-going updates of service delivery by LMHA/LBHA of referred Youth/Consumer.

The CMHSN+ will support and assist youth/ adolescents as they transition across different service locations and providers.
