PASRR Services

The intent of PASRR is to ensure that all nursing facility applicants are thoroughly evaluated, that they are placed in nursing facilities only when appropriate, and that they receive all necessary services while they are there, if they so choose. The individual will be assisted and provided with specialized services such as case management, occupational therapy, speech therapy, physical therapy, day habilitation, and independent living skills.

Services

Individuals are assisted in obtaining Medicaid or re-applying for Medicaid if it has been lost. Medicaid Specialists assist with completion of application/paperwork and also with relaying information to appropriate agencies as needed.

Determination of Intellectual and Developmental Disability

An assessment will be conducted by Coastal Plains' team consisting of a Psychologist and an Intake Worker. The result of the assessment is called a DMR Report and it is the basis for determining eligibility for services.

Intellectual Disabilities is measured by IQ assessment as follows:

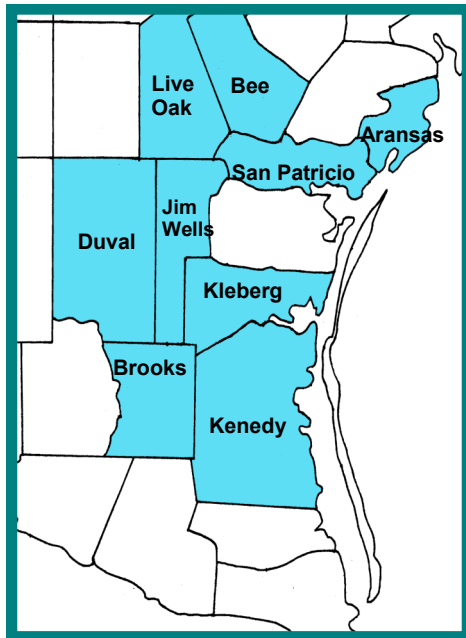
Mild - 50 to 55 through 69

Moderate - 35 to 40 through 50 to 55

Severe - 25 to 30 through 35 to 40

Profound - Below 2 to 20

Coastal Plains Community Center provides the following services for persons with Intellectual and Developmental Disabilities:

IDD Screening and Intake

Individuals who want Intellectual and Developmental Disability Services (IDD) have the opportunity to be referred for Intake to determine whether the individual is eligible for IDD services. This is determined by a licensed psychologist.

Service Coordination

Assistance is accessing medical, social, educational, and other appropriate services and supports that will help an individual achieve a quality of life and community participation acceptable to the individual and LAR on the individual's behalf.

Respite Services

The purpose of the respite services is to provide families with a temporary relief from their responsibilities as caregivers, and to also give those families an opportunity to take a break from one another.

Day Habilitation

A service provided at 4 day centers in a group setting to assist the consumers in improving self-help and independent living skills so that they can live and participate in the community.

Crisis Intervention Services

Provide therapeutic support and interventions to individuals with IDD or suspected of having a diagnosis of IDD who are experiencing behavioral and psychiatric crisis or challenges.

Crisis Respite

Out of home respite is a service provided at a setting other than the individual's home. The individual is in a 24-hour supervised setting in which therapeutic support is provided to stabilize the crisis situation prior to returning home. In home respite is a service provided in the individual's home, when appropriate, to provide therapeutic support to stabilize a crisis situation and to address the situational stressors.

Community First Choice

A service to determine eligibility to receive Community First Choice Personal Assistance and/or Habilitation Services. Assessments and IDD testing are completed and service planning coordinated with individual's MCO to determine appropriate services.
